


Regional Enforcement Allied Computer Team INVESTIGATION REPORT: NARRATIVE

On 10-27-2016, Suspect Crittenden was found guilty by a Jury, at the Hall of Justice in Santa Clara County, of PC 646.9(a), for stalking Victim Deputy David Carrol, a Sheriff's Deputy with the Santa Clara County Sheriff's Office. Suspect Crittenden has yet to be sentenced for this crime. This case is under docket number: C1642778. Suspect Crittenden is currently out of custody.

The major evidence, regarding the stalking charge, presented to the Jury by DDA Barbra Cathcart, included but was not limited to: e-mail's sent from Suspect Crittenden to private e-mail addresses not belonging to law enforcement or government agencies. These e-mails contained the home address of Victim Deputy Carrol, along with a map to his house and labeling him a criminal. This e-mail also contained the fact Victim Deputy Carrol had an ADT security system and the e-mail contained more than a dozen internet links to user manuals for ADT security systems. Suspect Crittenden also sent several e-mails indicating he had intimate knowledge of Victim Deputy Carrol's life- including the fact he was a Christian, owned a dog and owned a truck.

As part of the investigation into this case, I obtained the content of Suspect Crittenden's e-mail account. Within the e-mail account, I found evidence that Suspect Crittenden obtained a photo of Victim Deputy Carroll via the internet and manipulated the photo via photo editing software to only show Victim Deputy Carroll. The photo of Victim Deputy Carroll has been used in multiple web postings depicting Victim Deputy Carroll in a negative light. This same image of Victim Deputy Carroll is the same image used in the images depicted below.

On 2-26-2017 at 7:55AM, a post was made to the Facebook account "Santa Clara County Crime Family" regarding Victim Deputy Carroll. This posting is depicted below:



I also discovered a blog labeled "Manslaughter Coverup" at the following website: "manslaughtercoverup.wordpress.com." Within this blog, I located the following picture which was posted on 1-15-2017.

I obtained a Search Warrant for both accounts to determine who the creator of the accounts were and to obtain a preserved copy of the data on the account. On 3-15-2017, I obtained the data from

Facebook. As seen in the picture below, the registered owner of the Facebook account is listed as "Cary- Andrew Crittenden"



On 5-24-2017, I obtained the data from the Wordpress account. The creator of the account was not required to type in a name but registered for the account using the e-mail account: jmoore@sanfranmail.com with a username of "scccumb." The account was created on 12-31-2016 at 01:33 hours with an IP address off 209.36.107.146.

I conducted a search on the domain name Sanfranmail.com and it appeared to be in a non-functioning e-mail domain. I believe this e-mail account was used to attempt to disguise the true identity of the creator and user of the Wordpress account.

I cross referenced the IP address 209.36.107.146, which was used to create the Wordpress account, with the IP address log provided by Facebook for the above-mentioned account. The same IP address was used to access the Facebook account on 1-31-2017 at 00:24 hours.

I further analyzed the IP logs and saw the IP address 50.250.255.107 was used 11 times to post to the Wordpress account and the same IP address was used over 100 times to access the Facebook page. Due to the fact the Facebook Page and the Wordpress Page cover the same topic and use similar photographs, I believe the same person created both accounts. Due to the fact, the creator of the Facebook page is listed as "Cary-Andrew Crittenden" and identical IP address are used multiple times to access both pages, I believe the creator of both accounts to be Suspect Crittenden.

The posts made to these two accounts were made after Suspect Crittenden was found guilty for stalking Victim Carroll and I believe these postings show Suspect Crittenden is continuing to harass and stalk Victim Carroll.
